5.1 PYC Grant Application: The Ponoka Youth Centre submitted their annual grant application for 2022 with a request of \$30, 000.00. In 2021 the Board approved funds of \$25,000.00. Board members discussed the application.

21-66 Motion: Ed Seto moved that Ponoka FCSS approve the 2022 grant application from Ponoka

Youth Centre for the amount of twenty seven thousand dollars (\$27,000.00) to

come from eligible funds. Carried.

5.2 BB/BS 2022 Grant Application: The Ponoka Big Brother / Big Sisters submitted their annual grant application for 2022 with a request of \$25,000.00. In 2021 the Board approved funds of \$20,000.00. Board members discussed the application.

21-69 Motion: Debby Grant moved that Ponoka FCSS approve the grant application from Big

Sisters/Big Brothers for the amount of twenty-two thousand dollars (\$22,000.00)

to come from eligible funds. Carried.

5.3 Ponoka Ag Events Centre Society Grant Application: Board members discussed this grant application that requested support of \$3000.00. The Board has supported the application in previous years.

Centre Society in the amount of three thousand dollars (\$3,000.00) to come from

ineligible funds. Carried.
