1.0 Approval of Agenda

<u>18-59 Motion:</u> Tamara Armitage Cline moved to accept the agenda as presented. <u>Carried.</u>

2.0 Approval of Minutes

<u>18-60 Motion</u>: Kevin Ferguson moved to accept the June 11, 2018 minutes as presented. <u>Carried.</u>

3.0 Business Arising

- **3.1 Rimbey/Ponoka FCSS Board Joint Meeting:** It is our turn to host a Joint Board Meeting with the Rimbey FCSS Board. Shannon Boyce-Campbell will go over some ideas with Rimbey in order to find out what they may be interested in, such as a tour of the new library/learning center or possibly touring Centennial Centre.
- **3.2** Youth Bursaries Fundraiser Sept 29, 2018: Another fundraiser event is scheduled for September 29th and proceeds will come to the FCSS Youth Bursary fund.
- **3.3** Free Swim Report: We have received information from the pool regarding our FCSS sponsored swims. They have had approximately 393 swimmers in 8 evenings. They have reported that it is a very popular event at the pool. The Executive Director will inquire as to where they are sitting regarding money compared to number of swim times remaining.
- **3.4 FCSSAA Conference:** We have a smaller budget this year for the FCSSAA Conference being held in November. There is room for a few to attend and at this point there is no one registered. Please let the ED know if you are interested in attending as soon as possible.
- **3.5 Opera:** This is a grant application from Ponoka Secondary Campus requesting funds for two trips. One would target junior high and is scheduled in the near future; the other would be for high



school students in early 2019. Traditionally we have put \$5.00 towards the \$15.00 cost of the tickets and covered some of the busing costs. Each trip is approximately \$600.00.

<u>18-61 Motion</u>: Tamara Armitage Cline moved that Ponoka FCSS provide Ponoka Secondary Campus with funds in the amount of \$550.00 for one Opera trip in 2018 from ineligible funds to be used towards the costs of the opera trip. **<u>Carried.</u>**

4.0 New Business

- **4.1 Credit Card/Mastercard limit increase:** Administration requested an increase from \$8,200.00 to \$15,000.00. We have occasionally run into problems when booking multiple events and conducting day to day business therefore the increase is suggested.
- **18-62 Motion:**Alana Cissell moved that Ponoka FCSS increase the limit on the Mastercard from
\$8,200.00 up to \$15,000.00.**Carried.**
- **4.2** Four Directions Project Grant Funding Application: This is a grant application for a project estimated to cost \$30,000.00 with their request of FCSS being \$5,000.00. Board discussion followed.
- **18-63 Motion:** Alana Cissell moved that Ponoka FCSS provide funds in the amount of \$5,000.00 to support the Dark Spark Project out of ineligible funds. <u>6 Opposed Defeated</u>
- **4.3 Nelson Fund Updates:** The Elof and Thea Nelson Fund through the Calgary Foundation, provides approximately \$1,500.00 per year to cover fees associated with palliative care. Over the summer Lauraine Weir and Shannon Boyce-Campbell reworked the expectations of how the funds were to be utilized in order to meet the varied needs of a wider variety of local residents.
- **4.4 Handivan Contribution:** The board choose to allocate the already budgeted fund contribution from FCSS to the Handivan Society rather than at year end.
- **18-64 Motion:**Tamara Armitage Cline moved that Ponoka FCSS provide The Ponoka Covered Wagon
Handicapped Transport Society funds in the amount of \$10,000.00 from ineligible
funds.**Carried.**
- **4.5 Kidsport Contribution:** FCSS has budgeted an amount of \$2,500.00 in our 2018 fiscal year and would like to process that contribution at this time versus later in the year.
- **<u>18-65 Motion:</u>** Alana Cissell moved that Ponoka FCSS provide Kidsport funds in the amount of \$2,500.00 from ineligible funds. <u>**Carried.**</u>
- 4.6 Festival of Trees Financial Support Nov 15-17:
- **<u>18-66 Motion:</u>** Kevin Ferguson moved that Ponoka FCSS provide funds in the amount of \$500.00 from ineligible funds to the Festival of Trees. <u>6 Opposed Defeated.</u>

- **4.8** Lifeline Fees: This was a discussion regarding Lifeline fees going forward. The program is experiencing a deficit that would not be completely covered with an increase in fees but decrease it. The increased Lifeline monthly monitoring fee was discussed and detailed.
- **18-67 Motion:**Lynn Lawrence moved that Ponoka FCSS increase the monthly Lifeline fees from
\$30.00 per month to \$40.00 per month effective January 1, 2019. Carried.

- **<u>18-68 Motion:</u>** Kevin Ferguson moved that Ponoka FCSS provide funds in the amount of \$3000.00 from ineligible funds to sponsor the 2019 Winter Barrel Series. **<u>2 Opposed Carried.</u>**
